The actual collectable demand amount by the Municipality including both Past Arrears and Current Demand is only Rs.31.84 Crores. Out of which an amount of Rs.15.14Crores was already collected by this Municipality as on 31.10.2020 itself. This is 47.55% of the collectable demand.
