- 2. The Sealed envelope containing the Quotation should be superscribed as "Quotation for supply of Certificate vending and I.D. card" and submitted to the Office of the Commissioner, Pondicherry Municipality before the stipulated date and time.
- Quotations submitted after the stipulated date and time will be summarily rejected.
- 4. The EMD at the rate of 3% for the quote submitted should be paid in the form of the Demand Draft in favor of the Commissioner, Pondicherry Municipality. Failure to enclose DD for EMD shall result in rejection of the quotation.
- 5. Firms/agencies submitting quotation shall submit proof of having undertaken such work of printing ID Cards and Certificate of Vending for atleast 1000 nos. of Street Vendors in any Municipality in Puducherry or Tamilnadu. Quotations without such proof shall be summarily be rejected.
- 6. The Quotations will be opened on the same day 05.06.2025 at 5.00 P.M in the presence of the Commissioner & the representatives of the firm who may be present at the time of opening the quotation along with their specimen of CoV & ID card and authority letters.
- 7. No advance payment will be made on any account.
- 8. Rights are reserved to reject or accept any or all the quotation without assigning any reason thereof.
- The rate quoted will be valid for 120 days.

- 10. The supply should be effected within "10 days" from the date of receipt of the work order at your own cost.

- Maintenance Support for One year shall be provided to the Municipality. The vendor has to correct mistakes, photo mismatch, etc in the CoV and issue the same a fresh at free of cost.

#### 2. I.D card Specifications:

- 1. Street vendor I.D. card shall be printed in colour, clear and high quality medium and laminated with transparent plastic film end to end on both sides.
- 2. I.D. cards to be provided with tags.
- Cards are to be printed in bilingual.
- 4. The street vendor identity card shall be secured with a combination of QR code and unique identification number.
- 5. Editable soft copy of the I.D. cards shall be handed over to the Municipality.
- 6. I.D. cards shall be handed over within 10 days from the date of work order.
- Maintenance support of One year shall be provided to the Municipality. The vendor
  has to correct mistakes, photo mismatch, etc in the ID card and issue the same a fresh
  at free of cost.



#### TERMS & CONDITIONS OF VENDING

- 1. Validity of Certificate of Vending (CoV) From 24/07/2020 To 23/07/2023.
- 2. This CoV is issued based on request & must be produced on demand.
- 3. In case the street vendor to whom the CoV has been allocated suffers from any permanent disability, prolong illness or dies, then the certificate is valid for one of the family members in the following order of priority:
  - i. Spouse of the street vendor
  - ii. Dependent child of the street vendor, age as specified in State Schemes
- 4. Other than the above conditions at point (3), this CoV is non-transferable and the place specified in the CoV cannot be rented out to any other person.
- 5. Location / Space and CoV allocated is temporary in nature not having permanent rights.
- 6. The vendor shall not construct any permanent structure in allocated spaces.
- 7. The vendor shall not obstruct free movement of pedestrians and traffic,
- 8. The vendor shall maintain and upkeep the site allocated and dispose of their waste in appropriate dustbins.
- 9. The vendor shall not vend in any place other than the place mentioned in the CoV.
- 10. The vendor shall not cause loss to any public property.
- 11. The vendor shall pay rent / fee for the allotted site on first week of each month to each month to the concerned local authority @ rate as specified in ULB bye-laws.
- 12. The vendor shall carry out his vending during the time mentioned in the CoV.
- 13. The Urban Local Body reserves the rights to relocate the street vendor(s) to other locations under exceptional circumstances in the greater interest of the Public.
- 14. The issuing authority may impose any other conditions in the interest of the Public having regard to the category and nature of vending of Street Vendor.
- 15. The Vendor shall renew the CoV, as specified in the State Schemes, by depositing a fee as fixed by the issuing authority.
- 16. Loss of the CoV must be reported to the nearest Police Station and issuing authority.
- 17. Vending will not be permitted in No Vending Zone.
- 18. If the Street Vendor to whom the CoV has been issued violates any of the conditions of thereof or any other terms and conditions specified in the rules or Schemes of the State / UT for the purpose of regulating Street Vending, then the issuing authority, after giving an opportunity of hearing, cancel the CoV or suspend the same in such manner as specified in the scheme of the State and for such period as it deems fit.
- 19. The Vendor should ensure, the prohibited articles, and other low quality products are not to be sold.
- 20. The Vendor shall abide by the trade related statutory laws especially for trading food article.
