

MLA – LAD SCHEME (Member of Legislative Assembly - Local Area Development Scheme)

Introduction of MLA-LAD Scheme

MLA-LAD Scheme is being implemented by the Local Administration Department since 1997. They had 30 assembly constituencies and 3 nominated MLAs.

Scheme provides for

- Works of capital nature
- Suggested by the MLAs including nominated MLAs
- Rs.1.00 crore is allotted to each constituency / MLA

Corpus Fund in MLA-LAD Scheme

- Corpus fund in PUDA was created in 2014 and Rs.3 Cr fixed as the limit.

- Rs.60.00 crores allotted in the current Financial Year 2015-2016 (includes Rs.27 cr for 2014-15 & Rs.33 cr for 2015-16).
- File has to be moved 20 times to draw Rs.60 cr under Corpus Fund Scheme.
- Works are also expected to be completed by December, 2015 / January, 2016.

Status Of Works Under MLA-LAD

- Works for 2014-15 & 2015-16 sanctioned as per guidelines. Most of the works relate to laying of Roads and construction of drains
- For FY-2014-2015 all works have started and are nearing completion-Expected to be completed by October-2015. This implies a demand for remaining 27 cr. At once.
- For FY-2015-2016 works have been tendered out and some have commenced and work orders are being issued for the remaining.
- Expected to be completed by December-2015. This implies a demand for 33 cr. At once.

Proposal

- Hon'ble Chief Minister has assured during the budget speech for the FY-2015-16 that Block Sanction will be issued.
- Issue of Block Sanction for Smooth implementation and monitoring of the works in MLA-LAD Scheme.
- Release funds for two Block Sanctions to PUDA.
